#### SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Prior to and throughout the pandemic Central Queens Academy (CQA) school leaders have endeavored to engage, and learn from teachers, paraprofessionals, parents, and other community members in support of student learning. Engagement has taken the forms of Zoom meetings, Opinion Surveys, and personal contact via email and telephone. Topics shared in the dialogue among stakeholders have included:

- 1. Data on the school's mode of instruction (remote, hybrid, in-person) and student attendance in each modality; the manner in which funds are allocated to meet student's social, emotional, and academic needs through evidence-based interventions, how they advance equity for underserved students and how they sustain and support access to early childhood education programs;
  - 2. Student data, disaggregated by student subgroup, related to how the COVID-19 pandemic has affected instruction and learning;
  - 3. Guidance from the CDC, NYSDOH, and NYSED; and
  - 4. Decisions detailing school operations.

School leaders have developed strategies and implemented public health protocols for these topics, which include policies in line with guidance from the CDC for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff. Funds are used to implement prevention and mitigation strategies. They support:

- 1. Procurement of PPE and other supplies/materials for cleaning and sanitizing to ensure personal safety for all stakeholders while attending school;
- 2. Professional development for teachers and other staff members designed to reduce the loss of learning by each student during the pandemic, while attending to their social and emotional needs and;
  - 3. Assurance the school's ventilation and filtration systems meet NYDOH guidelines.

CQA will implement diagnostic, formative, and summative assessments to measure initial standard mastery. Teachers will use the data from the assessments to adjust lessons and create targeted small groups based on learners' shared needs. During the Phase I of CQA's reopening, diagnostic assessments will be administered in reading and math. The data from the diagnostic assessments will be used to create appropriate small groups for learners. As CQA enters phase II, we will continually assess the content understanding and skill mastery using the following mean:

CQA implements authentic assessments as the measurement of "intellectual accomplishments that are worthwhile, significant, and meaningful," as contrasted to multiple choice standardized tests. Authentic assessment will be devised by the teachers. Teachers will continue using data to analyze each scholar's content and skill mastery to identify next steps for individual learners. CQA teachers are well-trained to analyze student data and identify their student's strengths and knowledge gaps. That data analysis will then be used to adjust units, lessons, and small group instruction. CQA will continue to use the longer-range diagnostic data provided by our IA program, F&P testing, IXL diagnostic, and Renaissance STAR assessments to monitor student growth over baseline. CQA's instructional leadership team (ILT) will continue to use this data to moderate and fluctuate student groupings, intervention plans, and deeper enrichment readiness

CQA will use its allotted American Rescue Plan (ARP) funding to fund literacy intervention teachers in each grade level during the 2022-23 school year and the beginning of the 2023-24 school year. These teachers will work with students who have experienced learning loss and are below grade level in literacy. In addition, CQA will devote some of its ARP funding to support students socially and emotionally after having experienced isolation and possibly anxiety due to COVID-19. This support will be provided by a guidance counselor or social worker whose salary comes from ARP funds.

- 1. The systematic use of assessment data to guide instructional effectiveness and student learning. Teachers compile student performance data using Illuminate Education that stores student information over multiple years so that we can identify grade and school trends. These detailed analyses at multiple levels inform instructional planning and professional development.
- 2. Decisions based upon the data lead to the selection of evidenced-based solutions, both instructional programs, and focused professional development.
- 3. Once implemented, students are tested frequently to gauge the effectiveness of each solution then modifications are made and the process is
